**What about testing requirements?**

**Rising Fifth Year Students and Post-Bacc Students going into their Internships in the fall 2020, and provisionally admitted students**

Students will have until the end of the fall 2020 semester to take and pass their required testing for their program\*. Please be advised that students who have reached the credit limit as provisional admits will not be able to take further courses in their programs beyond the end of the fall 2020 semester's last day of exams, December 11th, until their testing is passed. Students have the right to appeal these decisions if there are factors beyond their control that affect whether they are able to register and pass the tests; however, interns cannot be licensed through UMW without passing their licensure testing.

<b>Elementary:</b> RVE, VCLA, Praxis 2
<b>Secondary/PK12:</b> VCLA and content-area Praxis 2
<b>SPED:</b> RVE, VCLA
